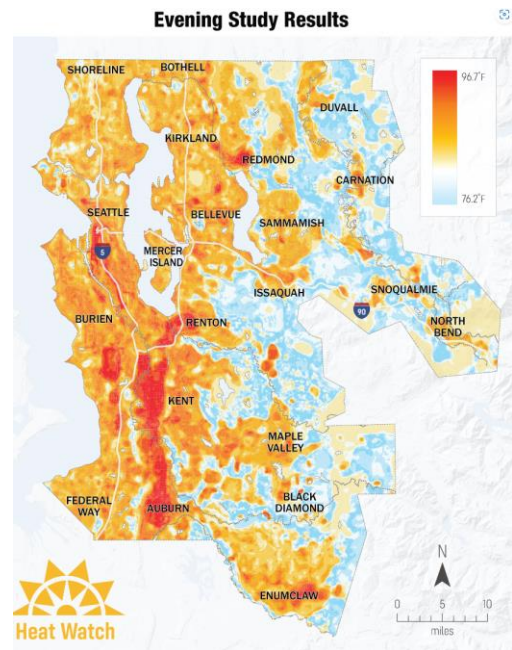

Become a CHAMPION Today!

Public Health Seattle & King County (PHSKC) is seeking community members in Auburn to join a year-long work group focused on heat and health. The **Climate and Health Adaptation Mapping Project (CHAMP)** needs 15 people to join a dedicated work group of “CHAMPions.” As extreme heat events become more frequent and intense due to climate change, King County is experiencing increased exposure to unhealthy heat levels. Participants in the CHAMPions workgroup will work together alongside public health practitioners, scientists, and policymakers, to visually represent the causes and effects of heat on health in Auburn.



Between July 2024 and April 2025, CHAMPions will attend six half-day meetings (Saturdays 10am to 1pm) and build a large visual diagram to represent how heat affects health in Auburn and potential solutions.

Duties:

- CHAMPions must attend six in-person half-day meetings in Auburn
 - **First three meeting dates: July 27, August 24, and September 14**
 - Remaining meetings will be held between October 2024 and April 2025
- Provide ongoing feedback for an evaluation of the CHAMP process

Compensation:

- **CHAMPions will receive hourly compensation comparable to other PHSKC programs** for participating in workshops and evaluation activities
- Food and childcare coverage will be provided as needed so that CHAMPions can attend meetings
