XII. MAYOR AND COUNCILMEMBER REPORTS

A. From the Council

Deputy Mayor DaCorsi commented on the Educator and Student protests in Auburn last week and on some of the small businesses opening in Auburn.

Councilmember Baggett reported he attended the Tacoma-Pierce County Board of Health meeting.

Councilmember Brown stated he is proud to live in a city that is actively fighting against racism.

Councilmember Jeyaraj commented on the Supreme Court's ruling protecting LGBTQ Americans from being discriminated against at work. He also commended the organizer of the Educator and Student protests and stated the city needs to ensure the excessive use of force happening in other cities does not happen here.

Councilmember Stearns stated his appreciation for the Educator and Student protests and the work they are doing. He also attended a webinar on police brutality and commented on the historic ruling by the Supreme Court making it illegal to discriminate against someone in the work place for being a part of the LGBTQ+ community.

B. From the Mayor

Mayor Backus spoke about her excitement regarding the Supreme Court Ruling protecting the LGBTQ+ community in the work place. She also stated she has been meeting with community leaders regarding how to make Auburn better and spoke about creating community teams to help make positive impacts for the City of Auburn residents.
