- A. Ordinance No. 6764 (Thomas)(20 Minutes)

An Ordinance amending Ordinance No. 6693, the 2019-2020 biennial budget Ordinance, as amended by Ordinance No. 6712, Ordinance No. 6719, Ordinance No. 6720, and Ordinance No. 6751, authorizing amendment to the City of Auburn 2019-2020 budget as set forth in schedule "A" and schedule "B"

Director Thomas reviewed the sixth budget amendment for the biennium and the second budget amendment for calendar year 2020.

Council discussed the Auburn Avenue Theater purchase, the impact of the Federal minimum wage on the Park's Department budget, the Teamsters contract and how drug seizure money is received and allocated.

B. Planning Commission and Land Use Legislative Process (Tate)(20 Minutes)
Overview of Planning Commission role in local land use legislative process

Manager Dixon provided Council with an overview of the Planning Commission. He explained what a Planning Commission is, their role in the legislative process, the land use legislative process, Auburn City Code basis for the Planning Commission and how the Planning Commission's key role is helping to set the long term direction or vision for the community's future.
